

General Terms and Conditions

1. Introductory Provisions

These General Terms and Conditions are issued by Tarsier II s.r.o., Company ID: 06716831, with its registered office at Pod Nuselskými schody 1721/3, 120 00 Prague 2 – Vinohrady, registered in the Commercial Register maintained by the Municipal Court in Prague, file no. C 287724.

These terms govern the use of the website and services provided by the hotel Podhlavický Mlýn. By using the website, the user agrees to be bound by these terms.

Tarsier II reserves the right to modify these terms or the website content at any time.

2. Reservation Terms

The hotel website allows online booking of accommodation, or reservations can be made via email and telephone contact. All reservations are concluded directly with the operator of Hotel Podhlavický Mlýn and become valid upon written confirmation from the hotel, either by email or through the booking system. The hotel operates without a reception; all information regarding accommodation, including access instructions to the property and the room, is provided to guests electronically prior to arrival.

Tarsier II is not responsible for costs related to travel to/from the property, including transportation, insurance, lost items, medical care, etc.”

3. Cancellation Policy

Reservation cancellations are subject to the following conditions:

- Free cancellation:
 - Cancellations made up to 48 hours before the scheduled arrival date are free of charge.
 - No fees will be charged for cancellations made within this period.
- Cancellation less than 48 hours before arrival:
 - A cancellation fee equal to 100 % of the first night will apply. The remaining nights will be canceled free of charge.
- Same-day cancellations or no-shows:
 - In case of cancellation on the day of arrival or no-show, a cancellation fee of 100 % of the total stay will be charged.





For special events (e.g. themed dinners, wellness packages on fixed dates) that are prepaid, no cancellation or refund is possible.

According to Section 1837, letter j) of Act No. 89/2012 Coll., the Civil Code of the Czech Republic, the guest has no right to withdraw from the contract within 14 days without stating a reason, as the agreement concerns leisure services provided on a specific date.

4. No Smoking Policy in Rooms

Smoking is strictly prohibited in all rooms at the hotel. In the event of a violation, the hotel reserves the right to charge a **cleaning and damage fee of CZK 5,000** to cover deep cleaning, odor removal, and room downtime. The guest acknowledges that this fee may be charged to the payment card provided during the booking process or at check-in.

5. Vouchers

Purchase of Vouchers

Vouchers can be ordered via the hotel's website using the online form or by contacting the hotel via email or telephone. The order must include basic customer information and the selected voucher type. By placing an order, the customer confirms that they have read and agree to these General Terms and Conditions.

The offer of vouchers available on the Podhlavický Mlýn website is for informational purposes only. Tarsier II is not obliged to conclude a contract solely based on the fact that a voucher is listed on the website. A contract is deemed concluded only when the order is confirmed and sent to the email address provided by the customer. The terms of use of the voucher (especially its validity period and value) are stated on the voucher itself. Further information on purchasing and redeeming vouchers is provided in these General Terms and Conditions.

Payment Terms

The website includes information about voucher prices and their respective types. All voucher prices are listed with 0% VAT, as they are not subject to value-added tax. The price of the voucher corresponds to the nominal value printed on the voucher.


Vouchers cannot be exchanged for cash, nor can they be combined with other vouchers, discounts, or special offers. Each voucher is valid for one-time use only.

Voucher Redemption

The customer is responsible for providing accurate contact details. If an incorrect email address or phone number is provided, Tarsier II cannot guarantee delivery of the reservation confirmation.

Each issued voucher is unique and must not be copied. Redemption is possible only by using the unique code printed on the voucher. Once the voucher has been properly redeemed, its





validity expires, regardless of any later cancellation or modification of the reservation, or in the event the accommodation is not used. In such cases, Tarsier II is under no obligation to reactivate the voucher or issue a replacement.

Validity

Each voucher has a limited validity period. The voucher must be redeemed before its expiration date, which is clearly stated on the voucher. If the holder fails to redeem the voucher in time and in accordance with these conditions, the voucher becomes void without any entitlement to a refund.

All content on the website is protected by intellectual property law. Unless otherwise stated, all rights belong to the website operator.


